SESSION INFORMATION

Sessions are every 2nd & 4th Tuesday from 12:00 - 1:00 PM MST.

Session Registration: Zoom registration links are provided via email announcements the Monday before each session. Register individually for each session you want to attend.

Session Structure: The first half of MOUD ECHO sessions is a didactic presented by the hub team. The second half of the session is a de-identified case presentation by a participant.

Recording Notice: Presentations are recorded so please mute yourself during the presentation. Hub team members will answer questions in the chat and at the end of the presentation. Q&A and case presentations are never recorded.

Education Curriculum: The MOUD ECHO curriculum is updated for 12-week cycles to cover core content, special topics, and guest presenters. Core content includes key aspects of prescribing with a focus on buprenorphine in clinic settings, including an overview of MOUD, psychosocial supports, and clinic-level resources and skills.

PROGRAM PARTICIPATION

Participation: MOUD ECHO follows the Project ECHO Model. Participation and collaboration

are a critical part of the model. Please introduce yourself to the hub and network when you join a session. You should plan to participate in case reviews and present a case at least once. If you do not participate at sessions, you may be removed from the session and/or listserv.

CASE REVIEWS

Volunteer to present a case at an upcoming session!

Every MOUD ECHO session provides 30 minutes for participants to present de-identified patient/client questions for input from subject matter experts on the hub team and other providers from the network. Scheduled case reviews are always given priority at sessions but ad hoc cases are welcome. Simulated cases based on general questions are also welcome. Every participants is expected to present a case at least once, so please volunteer to present!

How to Present a Case:

- 1. Fill out as much of the 2-page form of you can.
- 2. Anonymize your form. Real patients must be de-identified.
- 3. Submit the form to the program coordinator prior to the session: rmabeyta@salud.unm.edu

Please ensure no identifying information regarding the patient is conveyed in your form or verbal presentation. This includes even small details about the client/patient, their family, friends, workplace or similar that could identify them.

The Hub team will be prepared to go through the case with you and facilitate discussion at the session. A form with the summary of recommendations will be provided to you after the session.

CONTINUING EDUCATION

Attend 8 sessions to fulfill all DEA education requirements!

All session participants receive an email with continuing education information 1-2 business days after each session. The information is also provided below and can be saved for easy access.

CMEs: Each session offers <u>1.0</u> *AMA PRA Category 1 Credit tm* towards Continuing Medical Education (CME). Our CME credits are provided through the New Mexico Medical Society (NMMS). Our CME credits fulfill New Mexico Medical Board Pain Management requirements as

well as DEA education requirements for the MATE Act. Our CME credits also meet CNE contact hour requirements for the New Mexico Board of Nursing.

CEUs: Each session offers <u>1.0</u> credit towards Continuing Education Units (CEU). CEU credits are provided through the New Mexico Counseling and Therapy Practice Board.

Notice: If you attend any session by phone (calling-in) or in a group setting (2+ people), the person who registers through zoom must send an email to **rmabeyta@salud.unm.edu** so all persons attending can be included in attendance and qualify for continuing education credit.
